INFORMATION ON THE PROCESSING OF PERSONAL DATA PURSUANT TO EU REGULATION 679/2016.

Pursuant to Articles 12-14 of the EU General Data Protection Regulation n. 2016/679 ("GDPR"), we hereby provide you with the information regarding the processing of your personal data that will be carried out by SNAM S.p.A, with registered office in Piazza Santa Barbara 7, 20097 San Donato Milanese (MI) (hereinafter the "Company"), in relation to the *Snaminnova Call4Start-up* and the *HyAccelerator Program* initiative (hereinafter the "Initiative"), which aims to identify the best solutions proposed by innovative start-up and SME in order to integrate them into the Snam business.

1. Purpose of processing and legal basis

Personal data will be processed for the purposes described below:

- Access to the Platform and its contents;
- Submission of the application;
- Selection of proposals;
- Selection of the winner.

The legal basis for the processing of personal data is the consent of the data subject to the processing of his/her data for the purposes above mentioned.

2. Processing modalities

Please note that all personal data made available will be processed in accordance with current legislation on the protection of personal data within the limits of the purposes described above.

The provision of data by the data subject is optional; therefore, in the event of refusal, participation in the Initiative will not be possible.

Snam will collect the following types of information:

- Contact information of those who intend to access the Platform, such as first and last name, e-mail address and telephone contact;
- If you decide to register a start-up on the Platform, after accepting the relevant rules, information about the start-up may be provided: Name, date of foundation, location, website, description of the start-up, description of the business model, description of the market and of the target customers, patent, 2019/2020 turnover, fundraising since the Incorporation;
- If you decide to participate to a specific challenge, you may provide information on: Content, communications, photos, images, audio files, other useful documents, any useful links, start-up pitch. This may be information in or about the content provided, such as the location of a photo or the date a file was created.

The personal data provided will be processed and collected in full compliance with the GDPR, in accordance with the provisions of law, by mean of modalities and within the limits to pursue the aforementioned purposes. If the Company intends to use the collected personal data for any other purpose incompatible with the purposes for which they were collected or authorised, the Company will inform the data subject in advance.

3. Personal data retention policy

The Company keeps the data collected on cloud in a form which permits identification of data subjects for no longer than is necessary for the purposes for which the personal data were collected or subsequently processed in accordance with the law, and in any case for 24 months.

At the end of this period, the data will be destroyed and/or deleted by the Data Controller

4. Categories of recipient to whom the data may be disclosed

The personal data provided and the information collected will be shared with Skipsolab, which - as provider of the platform - is the Data Processor, to enable it to provide the Service and the assistance for managing the platform, in accordance with the instructions provided by Snam. The personal data provided and the information collected will be shared with Cariplo Factory partner of DT&T Open Innovation Hub (OPIN), Snam supplier for Open Innovation services.

Without prejudice to the obligations provided for by the law for which personal data may be made available to the Judicial Authorities and/or the Police Forces, at their specific request, for the purpose of identifying the authors of any unlawful acts committed to the detriment of the Company, as well as made available during the phase of access to documents, personal data shall not be disseminated to unspecified recipients but are transmitted exclusively to the provider of the Services (Skipsolab) and to service providers who contribute to the provision of the Service or part of it.

The data centres are located in Ireland

5. Data Controller, Data Processing Delegate, Data Processor

The Data Controller is Snam, with registered office at Piazza Santa Barbara 7, San Donato Milanese; the Data Processing Delegate for Snam is the Executive Vice President of Transformation & Technology; the Data Processor is Skipsolab, which manages the data in accordance with the technical and information security specifications agreed upon in negotiations.

6. Rights provided for by law to data subjects

Pursuant to Articles 15-22 of the GDPR, the data subject has the right to:

obtain confirmation as to whether or not personal data concerning him or her are being processed, even if not yet recorded, and its communication in intelligible form;

obtain the following information:

- a) the source of the personal data;
- b) the purposes and modalities of processing;
- c) the logic involved if the personal data are processed by mean of electronic

tools;

- d) the identification details of the data controller, data processors and the representative designated pursuant to Article 5(2);
- e) the recipients or categories of recipient to whom the personal data may be disclosed, or who may become aware of them as designated representative in the territory of the State, data processor(s) or person(s) in charge of the processing;

obtain:

- a) updating, rectification or, where interested therein, completing of the data;
- b) the erasure, anonymization or blocking of data processed unlawfully, including data whose retention is unnecessary in relation to the purposes for which they were collected or subsequently processed;
- c) the declaration that the operations carried out according to letters a) and b)
 have been communicated, also with reference to their contents, to each
 recipient to whom the personal data have been disclosed, unless this proves
 impossible or involves disproportionate effort compared with the right that
 is to be protected;
- d) data portability: the right to receive personal data in a structured, commonly used and machine-readable format and to transmit such data to another controller, where the processing is based on consent and is carried out by electronic means. To object, in whole or in part:
 - for legitimate reasons, to the processing of personal data concerning him/her, even though they are relevant to the purpose they were collected for;
 - to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising material or market research or commercial communication.

Pursuant to the same article, it is provided the right to request the erasure, anonymization or blocking of data processed unlawfully, and to object in any case for legitimate reasons to their processing.

We remind you that, as data subject, you may withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.
